



Acceptance of Terms of this Agreement through Use

1. Softball Canada maintains a registration database currently located at www.softball.ca/database (the "Database") which provides registration within Softball Canada. The Database is provided to you subject to your compliance with the terms and conditions of use defined in this Agreement. By registering with the Database you agree to be bound by this Agreement. If you do not agree to be bound by this Agreement, please do not register with the Database.

Modifications to this Agreement

2. Softball Canada reserves the right to change this Agreement at any time and your continued access to or use of the Database after such changes indicates your acceptance of this Agreement as modified. It is your responsibility to review this Agreement regularly.

Children

3. The Database is not intended for use by minors, especially those under age 13. To access, use or register with the Database, minors must get prior permission of their parent(s) and/or legal guardian(s). By your use of the Database, you represent and warrant that you are the age of majority or have sought permission from your parent(s) and/or legal guardian(s).

Privacy and Protection of Personal Information

4. By agreeing to the terms of this Agreement and completing the registration process you are providing Softball Canada with personal information, including name, address, email, telephone number, gender and date of birth. This information may be used by Softball Canada in accordance with the Softball Canada's Privacy Policy, including but not limited to, sending communications with regard to national, provincial/territorial and/or local programs, events, promotions and sponsorships. This information may also be used by Softball Canada for annual registration and membership demographics, internal record keeping and generating statistics; and in the case of medical emergencies.
5. Furthermore, personal information provided will be used by Softball Canada of the purpose of administering your provincial/territorial or national softball membership.

Use of Photographs, Videos and Images

6. You understand and agree that Softball Canada and its Provincial and Territorial Associations have the right to take photographs, videotape or digital recordings of you at its programs to be used in any and all media. You are aware that by giving consent, you are permitting your name to be kept in the National Membership Database and other Provincial/Territorial Association websites and publications, which can be viewed by anyone who accesses the National Membership Database or Provincial/Territorial Association websites or publications.

Conduct

7. You may not use the Database:
 - a) For the purposes of fraud or for any activity that contravenes the laws of Canada or any other applicable jurisdiction.
 - b) To engage in activities that cause or are likely to cause disruption or denial of service to any user of the Database.
 - c) To impersonate any other person.

Jurisdiction

8. The Database is established and operated in accordance with the laws of Canada and this Agreement will be interpreted in accordance with the laws of the Province of Ontario. You hereby consent and submit to the exclusive jurisdiction of the courts of the Province of Ontario in any action or proceeding related to this Website and agree not to commence any such action or proceeding except in Ottawa, Ontario, Canada.
